

**To Christian & Barton From Points North:**

Follow 95 South to Richmond.

Take exit 75/Downtown/3rd Street; it is in the far right lane. Proceed south for several blocks, eventually crossing Broad, Grace, Franklin and Main Streets.

Turn left onto Cary Street (one way). Stay in the left lane and, immediately after crossing 9th Street, turn left into the SunTrust Bank customer parking deck. Bring your parking ticket with you for validation.

Walk out of the deck and up 9th Street. The Mutual Building will be on your right (there is a Scott & Stringfellow Dow Jones readout monitor on the corner of the building). Come to our main reception area on the 12th floor.



**To Christian & Barton From the Airport and Points East:**

Follow 64 West to Richmond.

Merge onto 95 South via exit 190, 5<sup>th</sup> Street/Downtown. Get in the right lane. Proceed for several blocks, eventually crossing Broad, Grace, Franklin and Main Streets.

Turn left onto Cary Street (one way). Stay in the left lane and, immediately after crossing 9th Street, turn left into the SunTrust Bank customer parking deck. Bring your parking ticket with you for validation.

Walk out of the deck and up 9th Street. The Mutual Building will be on your right (there is a Scott & Stringfellow Dow Jones readout monitor on the corner of the building). Come to our main reception area on the 12th floor.



**To Christian & Barton From South of the James River (Richmond):**

Take the Powhite Parkway North. After crossing the James River, bear right towards 195 East/Downtown Expressway.

After the toll, take the 7<sup>th</sup>/9<sup>th</sup> Street exit, and stay in the right lane to briefly merge on East Byrd Street. You will now be in the left lane on East Byrd Street. At the light, turn left onto 9<sup>th</sup> Street, and get in the right lane.

Bear right onto Cary Street and immediately cross over to the left lane. Turn left into the SunTrust Bank customer parking deck. Bring your parking ticket with you for validation.

Walk out of the deck and up 9th Street. The Mutual Building will be on your right (there is a Scott & Stringfellow Dow Jones readout monitor on the corner of the building). Come to our main reception area on the 12th floor.

**To Christian & Barton From Points South:**

Follow 95 North to Richmond.

Merge onto 195 North via exit 74A, 195 Downtown. Take the Canal Street/Route 60 exit. There is a toll. Make slight left onto Canal. Get in the right hand lane. At 9<sup>th</sup> Street, turn right.

At next light, bear right onto Cary Street (one way). Immediately cross over into the left lane and turn left into the SunTrust Bank customer parking deck. Bring your parking ticket with you for validation.

Walk out of the deck and up 9th Street. The Mutual Building will be on your right (there is a Scott & Stringfellow Dow Jones readout monitor on the corner of the building). Come to our main reception area on the 12th floor.



**To Christian & Barton From Points West:**

Take 64 East to Richmond.

Take the Interstate 195 South/Downtown Expressway exit. Follow the signs to Downtown. After the toll, take the 7<sup>th</sup>/9<sup>th</sup> Street exit.

Turn left onto 9<sup>th</sup> Street. At the second light, bear right onto Cary Street. Immediately cross over into the left lane and turn left into the SunTrust Bank customer parking deck. Bring your parking ticket with you for validation.

Walk out of the deck and up 9th Street. The Mutual Building will be on your right (there is a Scott & Stringfellow Dow Jones readout monitor on the corner of the building). Come to our main reception area on the 12th floor.
